Key words: dates of publication; signatures; wrappers; *Notes from the Leyden Museum*. Although the wrappers appear to list the contents they are occasionally inaccurate; in addition some papers that were published in two parts were explained in the wrappers but there are a few cases where they were not. With the help of a full set of wrappers, the backs of which were sometimes used to complete the text, it is possible to explain all the inconsistencies (except two, one in Vol. 11 and one in Vol. 29).

Introduction

During October 2003 I examined several early volumes of *Notes from the Leyden Museum* together with Prof. L.B. Holthuis. We did so because we found that in certain cases the evidence for where one issue ended and another began was not completely clear. It seemed to us that, as in the *Proceedings of the Zoological Society of London* at that time, there was some printing technique used that allowed an issue to begin on the back of a page printed for the preceding issue, but also that the methods used by the printers differed from case to case. This led us to the discovery that some Notes were announced as split between two issues, but that other similar splits had occurred without clear signals. This raised the possibility that the dating of some scientific names might have been or might in future be confused.

This study became an extension of similar work on the *Proceedings of the Zoological Society of London* (Dickinson, in press), and with Drs. Florence Pieters on *Nederlandsch Tijdschrift voor de Dierkunde* (Pieters & Dickinson, 2005). The main objective was to establish with certainty where issues did begin and end, and I hoped to explain how the printers had dealt with cases that seemed problematic when the page length required did not fit neatly into the number of pages (signatures) foreseen.

Evidence from wrappers and signature numbering

Throughout the 36 volumes of this journal the task of determining the contents of an issue seems to have been made simple and wholly transparent by the inclusion, after the table of contents, of dates of publication for each issue along with the mention of the numbers of the Notes in each issue. As far as I can determine the dates of publication here are accurate; they are certainly more accurate in some cases than the dates that may be found on the wrappers (and wrappers are all too often discarded when volumes are bound). It will be shown below, however, that the details of which Notes were in which issue are slightly less reliable.

Throughout the series the standard signature size was 16 pages; signature numbers appear at the bottom left hand corner of the first page of each one (e.g. on pages 1, 17, 33 etc.).

Different conventions exist for the use of asterisks with signature numbers. In the *Proceedings of the Zoological Society of London* and in *Nederlandsch Tijdschrift voor de Dierkunde* the third page in each signature usually repeats the signature number, but adds an asterisk and this throughout the volume¹. Thus, in these two journals, the sheets to be printed back-to-back had the same signature number but with the one to be printed on the back having an asterisk. The result, after folding and cutting, is that the asterisk appears on the next odd-numbered page (N. Roche, pers. comm.).

In the case of *Notes from the Leyden Museum* the printers (E.J. Brill, Leiden) used asterisks differently. They used an asterisk to signal a half signature (8 pages) and two asterisks to signal when one half signature follows another (as in Vol. 23)². The use of half signatures allowed paper wastage to be minimised in cases where the pagination overran the expected number of signatures for the issue. Some signatures or half signatures can be found that have been made into short signatures³.

The exact technique could usually be deduced from the complete run, with wrappers bound in, found in the library of the National History Museum, London. Just occasionally the information left some doubt as to what exactly the printers did and signature numbers and the presence or absence of asterisks have been considered in search of further clarification.

Findings

I set out details of the pagination based on this study in Table I. Below are some special comments in two groups of different significance.

a. Articles ('Notes') that were split:

Vol. 7 parts 1, 2 and 3. Notes XIV and XIX were both split and properly signalled in the wrappers and in the table of contents. These splits came after four full signatures and then again after six more full signatures.

Vol. 23 part 3. This seems to end on page 176 after 11 complete signatures, but in the middle of Note XXIII. This seems to be substantiated by the way this article is listed in the *Zoological Record*. However the listing by Hellmayr (1903) is of the whole paper. On page 177 where signature 12 would be expected one finds 12^{*}, and 12^{**} appears on page 185 (both signalling half signatures); signature 13 commences on p. 193. That two half signatures were used in place of one full signature suggests that pages 177-179 were printed twice and that signature 12^{*} is in part a

Those for Volume 23 show that Part 1 which ended with Note VI on page 57 and comprised three signatures and a half, and the wrappers show that page 57 first appeared on the wrapper; a second half signature (pp. 57-64) begins in the bound work on page 57 and is marked with two asterisks. Page 57 thus appears in a second state. In volume 24 Note I comprises 166 pages and is made up of 10 full signatures and a half signature with its last two pages blank; when Part 2 of this volume was printed signature 12 was begun on p. 167, and the original two blank (and unnumbered) pages at the end of signature 11were discarded.

replacement for those three pages. Curiously however the List of Contents for Part IV (on the inside of the front of the wrapper) lists the "Fortsetzung" of Finsch's paper beginning on page 177; presumably the inclusion of the reprinted pages 177 to 179 led to this correct but misleading indication. No new scientific names appear in pages 177 to 179.

Vol. 35, part 1. The table of contents suggests that all of Note IV was printed for part 2, the July 1913 issue. This is not correct; pages 78 to 80 were available within the 5 signatures of part 1 and the *Zoological Record* lists these pages of Ulmer's note on Trichoptera (Ulmer, 1912) for 1912 and the last pages for 1913. In this instance the split falls in the middle of the generic description of *Paduniella* (with the description of *Paduniella semarangensis* Ulmer following, and wholly in the 1913 issue). The journal's editor at this time, Dr Jentink, was ill and died in November 1913. Dr E.D. van Oort acted for him during his illness (per L. Holthuis).

b. Articles ('Notes') that needed an extra page or two:

Vol. 5 part 1. Five signatures did not quite suffice as pages 81 and 82 belong to Note XI of this part. Their texts do not appear on the wrapper. Signature 5 comprises pp. 65-80. Apparently pages 81 and 82, part of Note XI, were printed and issued with part 1, and reprinted at the beginning of signature 6 when Part 2 was printed.

Vol. 8 parts 2 and 3. The List of Contents on the inside of the front wrapper of Part 2 lists Note XVIII and page 131 (implying that the whole Note appeared then). The List of Contents on the inside of the front wrapper of Part 3 lists the "Fin" of Note XVIII and gives p. 133. So there appears to be a split, because pages 133-136 are the first pages of signature 9. Because 132 pages make 8¼ signatures it seemed likely that the question about Note XVIII might relate to a short signature, and that this might be made up of pp. 133-136. However the short signature would appear to be pp. 65-68 in Part 1. Part 2 seems to be made up of 4 signatures (pp. 69-84, 85-100, 101-116 and 117-132). A split thus seems to have been correctly signalled.

Vol. 11 part 1. Eighty-eight pages were printed and 'wrapped' and page 89 was printed on the inside of the back of the wrapper, but the wrapper curiously shows no evidence of the printing of page 90 and yet this page completed Note XX; indeed the description of a new Malayan cicada named *Kamalata pantherina* begins on page 89 and continues on page 90. Although a most unlikely scenario, it would *seem* that page 90 was first printed within Part 2. Signature numbering here provides no help; signature 6 begins on page 81 as "6" – no asterisk, but is a half signature (pp. 81-88). It is followed by a further half signature 6* (pp. 89-96)⁴. Evidence of an earlier state of page 90 would be of considerable interest.

Vol. 13 parts 1 and 2. Sixty-four pages were printed and wrapped; but pages 65 and 66, completing Note III, were not printed on the back of the wrapper and will have been printed in a "first state". When part 2 (signatures 5-9 pp. 65-144) was printed these two pages are at the start of signature 5 and will have been reprinted. In Part 2 pages 145 and 146 are printed on the back of the wrappers, and appear in their "second state" at the beginning of signature 10 opening Part 3. The plate relating

to the short article by Roelofs (pp. 145-146), and incorporating four other figures relating to three other notes in Part 2, was apparently not ready and followed in Part 3. One can imagine that Roelofs was keen to get his new species in print quickly.

Vol. 15 part 3. The wrapper contains the text of page 273, the last page of Note XXXVIII, which will have been reprinted when part 4 was printed.

Vol. 16 part '1 and 2'. The wrapper contains the texts of pages 117 and 118, the last two pages of Note V, which will have been reprinted when part '3 and 4' was printed.

Vol. 23 part 1. Ends with page 57 printed inside the back wrapper. When part 2 was printed page 57 was reprinted as the first page of a half signature (see earlier footnote).

Vol. 26, part 3. Page 199, the last page of Note III, was first printed on the inside of the back wrapper. The page will have been reprinted when part 4 was printed.

Vol. 28, part '1 and 2'. Page 145, the last page of Note IX, was first printed on the inside of the back wrapper. The page will have been reprinted when part '3 and 4' was printed.

Vol. 29, part 2. Note XIV ends on page 147 but part 2 seem to have comprised 9 signatures and to have continued on the wrapper where pages 145 and 146 duly appear. However page 147 does not seem to do so. All three pages will have been reprinted when part '3 and 4' was printed for signature 10 commences on page 145. As is the case of Volume 11 part 1 there must have been a way of extending the wrapper to print an extra page.

Vol. 30, part 1. Page 97, the last page of Note XIII, was printed on the back of the wrapper. This page will have been reprinted as part of the next issue.

Vol. 30, **part '2 and 3'**. Pages 217 and 218, the last pages of Note XIX, were first printed on the back wrapper. They will have been reprinted with the next part.

Vol. 31, part 2. Page 169, the last page of Note IV, was first printed on the back wrapper. It was reprinted for the next issue.

Vol. 32, part 1. Pages 81 and 82, the last pages of Note VIII, were printed on the back wrapper and will have been reprinted with the next issue.

Vol. 32, part '2 and 3'. Page 193, the last page of Note XVIII, was first printed on the back wrapper. It will have been reprinted as part of the next issue.

Vol. 34, part 1. Page 69, the last page of Note XIV, was first printed on the back wrapper and will have been reprinted for the next issue.

Vol. 36, part '1 and 2'. Page 161, the last page of Note XI, was first printed on the wrapper and will have been reprinted as part of the next issue.

Dates of publication

It will be remarked that in several instances the first issue of a new volume would appear before the last issue for the preceding volume. This occurred in the case of the first issues of volumes 24, 31 and 33.

Wrapper dates should not be used for dating purposes. Examples of their disagreements can be seen by comparison of the dates in Table I with the dates on the wrappers in volumes 18 part 1 with a wrapper dated January 1896, 19 part '1 and 2' with a wrapper dated 'Jan. & Apr.', and in volume 22 with parts '1 and 2', 3 and 4 with wrappers respectively dated 'Jan. & Apr. 1900', 'July, 1900' and 'Oct. 1900'.
